To: Contractors – Building Sewers/Water Service Laterals

Pursuant to the <u>Rules and Regulations</u> of this Department, any person or contractor engaged in the installation of building sewers and/or water service laterals on the County sewer and/or water system must:

- a) Be registered with the County.
- b) Post a Surety Bond as provided in the <u>Rules and Regulations</u> **annually** along with a **\$25.00 registration fee.**

Please find enclosed a Surety Bond for 2023. This Bond must be filled out in full (name, address and phone number) and submitted to your insurance agent. No Bond will be accepted without the 2023 Surety Form completed. Do not send continuing certificates or bonds prepared by an insurance agency. <u>Please use the enclosed form.</u> Also, all submittals must be accompanied by the \$25.00 registration fee (cash or check only).

You must have a 2023 Surety Bond on file with this office before an inspection will be scheduled for any building sewers and/or water service laterals after December 31, 2022.
