A Bid guaranty, as required by Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

A Certified check, cashiers check, or letter of credit equal to ten (10) percent of the bid will be required of the awarded supplier only within 24 hours of award notification. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must file a performance bond for the amount of the contract, and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

Attention of bidders is called to all of the requirements contained in the bid packet. No bidder may withdraw his/her bid within sixty (60) days after the actual date of the opening thereof. All bids shall be properly signed by an authorized representative of the bidder.

All bids shall be sealed and plainly marked "**Purchase 5000 Tons of Bulk Ice Control Salt with the Option to Purchase up to an additional 4000 Tons, May 23, 2011, 10:00 a.m.**"
