INVITATION TO BIDDERS

Separate sealed bids for materials for Lower Little Miami WWTP Sewage Sludge Hauling and Disposal Project will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners until 9:30 a.m., January 19, 2016, and then at said time publicly opened and read aloud in the Commissioners Meeting Room at 406 Justice Drive, Lebanon, Ohio 45036.

Bid packets may be obtained from the Warren County Office of Management and Budget, 406 Justice Drive, Lebanon, Ohio, (513) 695-1947. Questions regarding the technical specifications should be directed to David Walling, Deputy Sanitary Engineer for the Water and Sewer Department, at (513)695-1645. Each bid shall contain the full name of each person or company submitting the bid and be accompanied by a bid bond for the full amount of the bid or a certified check in the amount equal to ten (10) percent of the bid.

A Bid guaranty, as required by the Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to five (10) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must then file a performance bond for the amount of the contract and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

OR

2 A form of bid guaranty bond (attached) for the full amount of the bid. A bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed. Attention of bidders is called to all of the requirements contained in the bid packet.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof. All bids shall be properly signed by an authorized representative of the bidder.

All bids shall be sealed and plainly marked "**Bid Opening – Lower Little Miami WWTP Sewage Sludge Hauling and Disposal Project, January 19, 2016 @ 9:30 a.m.**"

Warren County reserves the right to reject any or all bids submitted, to waive any irregularities in bids, and enter into a contract with the Bidder who in Warren County's consideration offered the lowest and best bid.

The work to be performed at the Lower Little Miami WWTP includes hauling and disposal of approximately 8,500 wet tons of sanitary sewage sludge cake annually, with loads trucked out daily, Monday through Friday. Engineer's Cost Opinion for the project, including ancillary on-site trailers or roll-off dumpsters is \$315,000.00. Alternate bids for land application will not be considered at this time.
